This certificate, known as the Membership Record, shall be used as required by the Supreme Statutes (Division III, Chapters X, XIII, XIV, and XVI) in connection with the suspension, expulsion, reinstatement, transfer or withdrawal of members of the Order Knights of Pythias.

**EXTRACTS FROM SUPREME STATUTES**

3.16.01 "It shall be the duty of each subordinate lodge to prepare and maintain a membership record of each member \* \* \*. Such record shall show the place, date of birth, country of which he is a citizen, address, occupation, dates when the ranks of knighthood were conferred, honors attained, and information relative to his suspension, expulsion, reinstatement, withdrawal, transfer and death. \* \* \*"

3.16.02 "A typewritten transcript of the member's record shall be furnished by the subordinate lodge, on a form prepared by the Supreme Lodge, to a member upon his voluntary retirement or suspension from the order, or upon request, to the secretary of another lodge to which the member is transferring, reinstating or applying for dual membership. \* \* \*"

3.13.01 "When a member of a subordinate lodge has been suspended therefrom and from the order for non-payment of dues, it shall be the duty of the chancellor commander, attested by the secretary, forthwith to certify to such member the facts concerning his suspension, under seal of the lodge, mailing a copy of such certificate to the grand secretary. Such certificate shall contain the date of suspension, with information as to the manner and cost of reinstatement or re-affiliation with the order. This certificate shall be termed membership record and shall be furnished by the Supreme Secretary as an official supply. \* \* \*"

3.10.011 "Each grand lodge shall fix the respective fees to be charged by the subordinate lodges within its own domain, for membership by initiation, reinstatement or transfer, and if any grand lodge shall fail to fix such fees, the subordinate lodges within its domain may exercise said privileges under the same restrictions that are placed upon a grand lodge until such time as the grand lodge shall enact legislation upon the subject. Such fees must be paid before a ballot legally can be had."

3.14.01 "Any suspended member in possession of his membership record may make application to any subordinate lodge, accompanied by the fee fixed by law, subject to all the requirements a provisions pertaining to the reinstatement of a suspended member. If said application is favorably acted upon, the lodge to which said application is made shall notify the subordinate lodge which suspended said member or the grand secretary of the grand lodge which issued such certificate."

3.14.02 "A member expelled under the provisions of the Supreme Statutes may make application for reinstatement in writing, signed by himself. Such application shall be made on the form prescribed by the Supreme Lodge and must be accompanied by the amount required by law. \* \* \* A member expelled for arrearages shall be considered as suspended for non-payment of dues."
